The Chartered Accountancy (CA) course in India, governed by the Institute of Chartered Accountants of India (ICAI), is one of the most prestigious and rigorous professional qualifications for aspiring accountants, auditors, and finance professionals. It involves passing a series of exams, along with practical experience (articleship), to become a certified chartered accountant.



ELIGIBILITY

ELIGIBILITY

- After Class 12 (Commerce/Non-Commerce)
- Register for the Foundation Course after completing Class 12.
- After Graduation/Post-Graduation
- Graduates and postgraduates can directly enroll for the Intermediate Course without appearing for the Foundation Course, provided they meet specific criteria (55% marks for commerce graduates and 60% marks for non-commerce graduates).



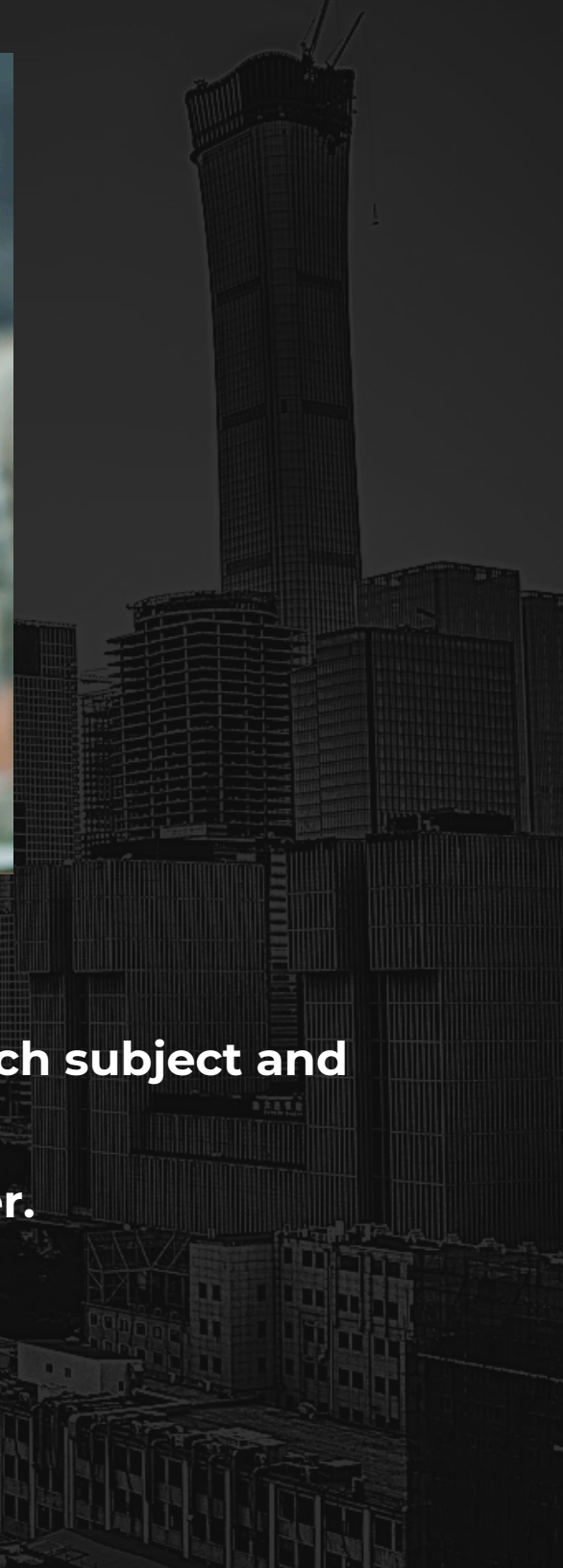
LEVELS IN CA

- The CA course consists of three levels:
- CA Foundation (Entry Level) : After Class 12.
- CA Intermediate (Mid-Level) : After passing the CA Foundation or directly after graduation/post-graduation.
- CA Final (Final Level) : After passing both groups of CA Intermediate and completing 2.5 years of Articleship.



EXAMINATION AND PASSING CRITERIA

- Each paper is of 100 marks, and a minimum of 40% in each subject and 50% aggregate in all subjects is required to pass.
- Examinations are held twice a year in May and November.





CAREER OPPORTUNITIES AFTER CA

- **Practice:** You can set up your own practice as an independent CA.
- **Corporate Roles:** CAs are hired for roles like Financial Analyst, Tax Consultant, Auditor, Chief Financial Officer (CFO), etc.
