Who Is Eligible for the CIA US ?

Bachelor's Degree (or equivalent) from an accredited university or college in any discipline. If you don't have a bachelor's degree, you may qualify through:

Associate's Degree (or equivalent), with additional experience requirements.

Seven Years of Verifiable Internal Audit Experience (without a degree). You must have relevant work experience in internal auditing, risk management, or a related field. The experience requirements depend on your educational background

SYLLABUS

CIA US Syllabus

- Part 1 – Essentials of Internal Auditing : Part one emphasizes the essentials of internal auditing. This section tests basic skill proficiency and understanding of internal auditing concepts, including governance, risk management, and control.
- Part 2 – Part two covers the practice of internal auditing. Managing, planning, and communicating the results of audits comprise 60% of this section's content. The other 40% tests proficiency in performing internal audits.
- Part 3 – Part three includes business-focused questions relevant to auditing. Topics include business acumen, financial management, information security, and information technology.



CIA US Fees

These fees vary based on your membership status with the Institute of Internal Auditors (IIA) and your location. IIA Membership Fees: Becoming a member of IIA India can lead to significant discounts on application and exam fees. Membership fees are approximately ₹3,500 plus GST per year, with a one-time payment of ₹1,500 plus GST.
