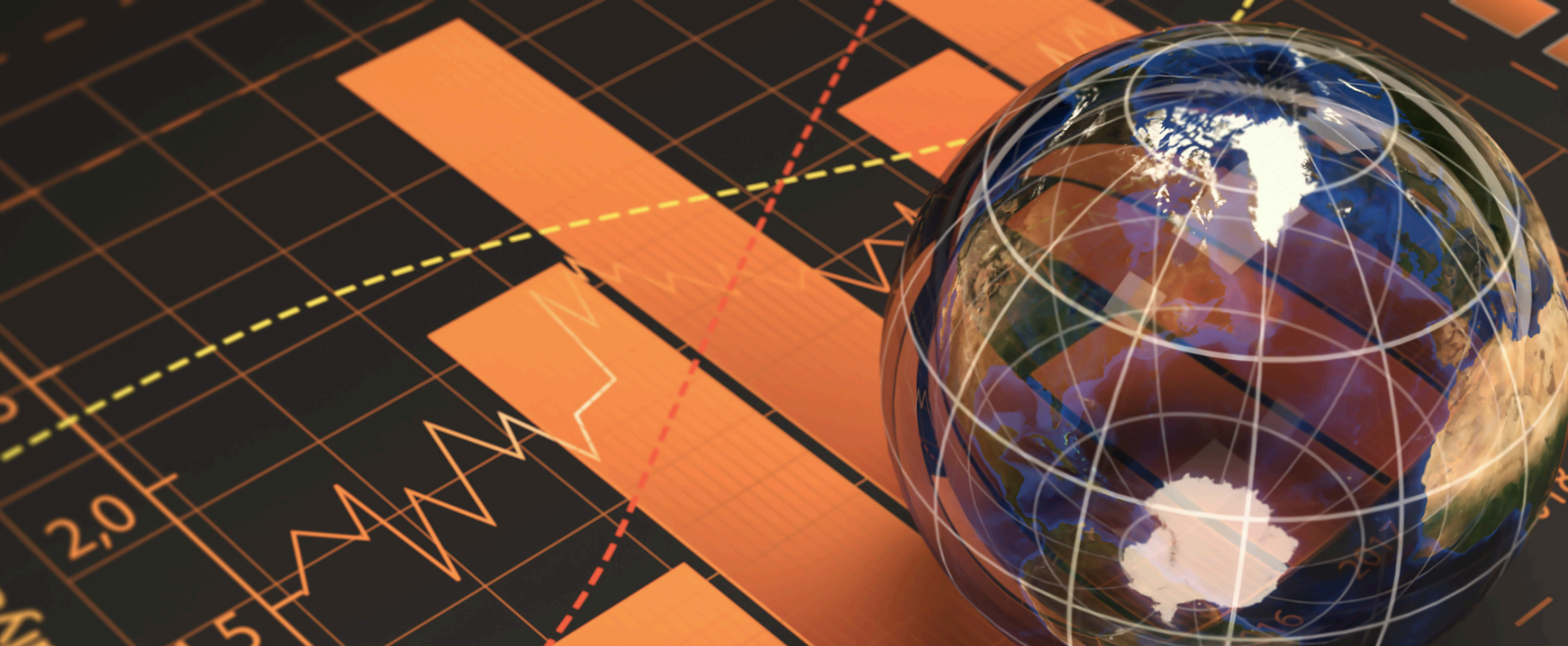

# **WHO IS AN ENROLLED AGENT ?**

**An Enrolled Agent (EA) is a federally authorized tax practitioner certified by the U.S. Internal Revenue Service (IRS) to represent taxpayers in matters related to taxation. Enrolled Agents specialize in tax laws, tax preparation, and taxpayer representation. EAs are the only tax professionals licensed directly by the IRS. They receive their authority to practice from the U.S. Department of the Treasury.**





## **WHO IS ELIGIBLE ?**

**There are no specific educational or degree requirements to become an EA. There are two main pathways to become an Enrolled Agent :**

- **Passing the Special Enrollment Examination (SEE)**
- **IRS Work Experience. You may qualify without taking the SEE if you have worked for the IRS for at least 5 years interpreting and applying tax laws.**





# **HOW TO BECOME AN ENROLLED AGENT ?**

**A prospective EA must first obtain a Preparer Tax Identification Number (PTIN) at [www.irs.gov/ptin](http://www.irs.gov/ptin). He/she then must pass all three parts of the SEE within a two\* year period (or apply and obtain approval based on certain prior IRS employment). Lastly, he/she must apply for enrollment using Form 23 and pass tax compliance and suitability checks. Upon receipt of an enrollment card, a new enrolled agent should update his/her credentials at [www.irs.gov/ptin](http://www.irs.gov/ptin).**





# **ENROLLED AGENT PAPERS & EXAM FORMAT**

**This is a three-part exam that tests knowledge of :**

- 1. Individual Taxation**
- 2. Business Taxation**
- 3. Representation, Practices, and Procedures**
- 4. Anyone can take the SEE—there are no prerequisites.**
- 5. You must pass all three parts of the SEE within a two-year period.**
- 6. 100 multiple-choice questions per part.**
- 7. 3.5 hours per part.**





# ENROLLED AGENT EXAM FEES

- Each part of the SEE costs approximately USD 203 (subject to change)
- PTIN fee is USD 35.95
- ENROLLMENT TO PRACTICE FEES USD 67
